Thank you for your interest in housing during the summer of 2021!

Each student who chooses to reside in summer housing must respect the policies and procedures as stated on the reverse side of your summer housing contract, in *The Guide to Residence Life*, and those specifically applicable to summer housing (listed below).

- 1. Residents must be a student **enrolled in an approved Chaminade summer program** and recommended by the host department.
- 2. Residency will be for the duration of the program **only**.
- Health insurance coverage is required and proof of insurance (copy of insurance card) and insurance information must be provided.

- 4. **Hale Pohaku** is an **alcohol and other-drug free** apartment complex. Smoking (cigarettes or ecigarettes) is not permitted in the residence halls or apartments.
- 5. Residents must keep the apartment, common areas and grounds clean, in good order and in good sanitary condition.
- 6. No person shall reside in apartment other than those authorized by Chaminade Residence Life Office.
- 7. Residents must occupy their assigned portion of the room **only** (i.e. do not store your personal belongings on the other side of the room, or in the adjoining room even if it is unoccupied).
- 8. Agree to allow the maintenance and cleaning crew access to the rooms for summer repairs, cleaning, carpet and/or furniture replacement as necessary.

COVID policies:

- 9. Guests and visitors are not permitted in the residence halls and apartments.
- 10. Residents must follow the designated pathways within the residence halls.
